### Special or sensitive personal data we manage

## With what goal and on which ground we manage personal data

G.T.D. Bernoulli manages your personal data with the following goals:

- to inform you about changes in our services and products
- to provide the possibility for setting up a personal account
- to organize activities and events
- to manage our member database
- to inform third parties of the composition our members base
- to create an almanac
- to create an overview of al members, only accessible by other members

## Automatic decision-making

G.T.D. Bernoulli does not take automatic decisions that could have (significant) effects on persons.

## How long we keep personal data

G.T.D. Bernoulli does not keep your personal data any longer than strictly necessary to achieve the goals for which it was collected in the first place. The data is kept during the membership and till a maximum of one year after deregistration.

## Sharing of personal data with third parties

G.T.D. Bernoulli only shares personal data with third parties to honor agreements with u or to meet governmental legislation. G.T.D. Bernoulli can share personal data with the following parties:

- Congressus, all shared information by members. This company manages our members database.
- Conscribo, name, student number, telephone number, e-mail address and IBAN-number. This is to manage the financial administration.
- Sponsors, personal data related to the event. The specific kinds of personal data that will be shared is communicated with the participants prior to the event.

## Reviewing, adjusting or removing data

To verify the legitimacy of the request we will ask you to send a copy of your ID along with the request.

When sending the copy, please sensor the following parts of your ID: personal photo, MRZ, ID number and citizens license number (BSN). This is to secure your privacy. We act on your request as soon as possible, maximally 4 weeks after the request was done. Finally, G.T.D. Bernoulli would like to point out that it is always possible to send any complains to the national supervisor, the "Autoriteit Persoonsgegevens".
